## PRIVACY ACT STATEMENT

AUTHORITY: 5 U.S.C. 552a; SECNAVINST 5211.5E; and MCO 5110.1C

PRINCIPAL PURPOSE: To record data for all vehicles to be registered aboard Marine Corps Base Hawaii and issued a Department of Defense form 2220, (DoD Decal). ROUTINE USES: The information provided on this form will be used complete the vehicle registration process upon issuance of a DoD decal or temporary vehicle pass. This information is entered into the Consolidated Law Enforcement Operations Center database (CLEOC), the Marine Corps' designated repository for crime reporting and registration information as required to track vehicles registered aboard Department of the Navy installations. Information may be disclosed to local, county, state, and federal law enforcement or investigatory authorities in the act of conducting an official investigation. Information gathered from this form may be used in other related criminal and/or civil proceedings as required by law.

DISCLOSURE IS VOLUNTARY: SSN is used to positively identify the individual applying for access to a federal installation and as a conduit to check past criminal records. Disclosure is voluntary, however failure to provide the requested information may preclude the vehicle from being registered or permitted to access MCRH.
