Nu'upia Ponds: An Ancient Fishpond Complex

The Nu'upia Ponds are part of the Mōkapu Peninsula Fishpond Complex at MCBH. Long ago, the fishponds were made by building walled sections on the reef area. Many shrimp and fish such as mullet and milk fish were once raised in the ponds. When Hawaiians used the ponds, they practiced ho'ihi (respect), laulima (cooperation), and mālama



(stewardship; caring for). This resulted in a lokāhi (balance). Today, the Nu'upia Ponds are a 482-acre Wildlife Management Area where the Natural Resource Managers and volunteer environmental stewards collectively known as the "Weed Warriors" work together to control invasive species so native flora and fauna can thrive.

Pu'u Hawai'i Loa: Commonly Known as KT Hill

This photo depicts the view from *Pu'u*Hawai'i Loa towards the eastern end of

Mokapu Peninsula, home of MCBH. In the

Hawaiian language, *pu'u* means "hill".

Hawai'i loa was a type of fishing line used

to catch *ulua* (giant trevally fish). Based

on traditional Hawaiian fishing practices,

Pu'u Hawai'i Loa may have been a

landmark used for identifying important

fishing grounds by line-of-sight with other

landmarks. Over the last 20 years,

archaeological studies identified Hawaiian cultural resources on *Pu'u Hawai'i Loa*. These resources include stone terraces, cupboards, walls, stone-lined planting pits, and Paper Mulberry trees or *wauke*, which were traditionally used for making *kapa* (bark cloth material). Today, *Pu'u Hawai'i Loa* is more commonly known as "KT Hill" for the aviation control tower built on its crest called Kansas Tower.

Register and Leash Your Pets

Free-roaming cats and dogs are a threat to terrestrial and marine wildlife. Native ground-nesting birds make their homes in shallow, underground burrows. Many birds are federally listed as threatened or endangered, so predation by loose cats and dogs is a serious concern. You can help by following Base Order P5233.2, Base Pet and Wildlife Regulations:

- Register your pets with the Animal Control Officer (257-1821).
- All pets must be microchipped.
- Keep cats inside your home.
- Report free-roaming cats to:
 - o Animal Control Officer (257-1821) or
 - Natural Resources staff (257-7129/7131)
- Dogs are not allowed at the beaches between 1000 and 1500.
- Pets must be kept on a leash and under your physical control outside of your home.
- Dogs are never allowed in the Nu'upia Ponds Wildlife Management Area (WMA).
- Adhere to signs and fencing at the boundaries of all Wildlife Management Areas.
- Contact the Animal Control Officer immediately if your pet gets loose (257-1821).
